





Preface

Foreword from the Minister of Natural Resources and Environmental Sustainability



I am delighted to present this comprehensive report encapsulating Malaysia's participation at the 28th Conference of the Parties to the United Nations Framework Convention on Climate Change (UNFCCC-COP28). Hosted with grandeur by the United Arab Emirates, which saw the participation of over 100,000 delegates, including 156 heads of state, making it one of the largest conferences convened in history. This report chronicles an overview of the outcomes of COP28's formal negotiation, Malaysia's proactive engagement in key events held on the sidelines of COP28, and the impactful presence of the Malaysia Pavilion.

In 2021, Malaysia updated its Nationally Determined Contribution, committing to a 45% reduction in greenhouse gas (GHG) emissions intensity by 2030 based on the 2005 level. Malaysia further declared its aspiration to achieve net-zero GHG emissions as early as 2050, subject to the outcome of Long Term-Low Emissions Development Strategies. Malaysia remains steadfast in implementing climate actions to mitigate emissions and build resilience, reaffirming its dedication to the Paris Agreement.

COP28, marked by historic significance, served as a poignant reminder for nations to expedite climate action as outlined in the UAE Consensus. The resounding call to transition away from fossil fuels reverberated, setting the stage for further emissions reductions and increased financial commitments to limit mean global temperature rise within 1.5°C.

One of the most significant outcomes of COP28 was the spotlight on financial commitments, which took center stage in the global effort to combat climate change. More than USD 85 billion in funding was pledged, marking a pivotal moment in mobilising resources for climate action worldwide. The establishment of the Loss and Damage Fund marked a strong start for addressing climate-related disasters.



On a positive note, over 50 oil companies committed to net-zero carbon emissions and substantial methane reduction by 2030, addressing concerns in the fossil fuel sector. Yet, as revealed by the 'global stocktake,' the world lags in meeting the 1.5°C warming limit agreed on in Paris, urging us to increase ambition and financing urgently.

COP28 also provided a platform for our nation to showcase the progress we have achieved in balancing economic development with environmental stewardship. It allowed us to share our experiences, successes, and learnings with the international community through the Malaysia Pavilion. The overarching theme, "Going Beyond: Green Growth, Resilient Community, Sustainable Planet" guided our collective efforts, emphasising our dedication to climate action while harmonising with national priorities.

The Malaysia Pavilion as a collaboration hub had featured 138 international and local speakers and fostering partnerships worth a staggering USD 9 billion in just two weeks. Our nation's active role was further underscored by leadership on various fronts, including the intersection of Islamic finance and climate change, the National Energy Transition Roadmap, and protecting our natural assets.

This year's COP29 is slated to take place in Azerbaijan, with anticipation for the subsequent event in Brazil. Over the next two years, a pivotal period unfolds. COP29 necessitates governments to articulate a robust climate finance objective adequate with the gravity and immediacy of the climate crisis. Subsequently, at COP30, comprehensive nationally determined contributions are imperative – encompassing all greenhouse gases and impeccably aligned with the stringent 1.5°C temperature threshold.

Let us carry forward the collaborative spirit ignited at COP28. Our gratitude extends to sponsors, dedicated negotiators, partners and speakers and all stakeholders who played pivotal roles in shaping a brighter and sustainable tomorrow.

Introduction

Background of UNFCCC

The United Nations Framework Convention on Climate Change (UNFCCC) is an international treaty adopted in 1992 during the Earth Summit in Rio de Janeiro, Brazil. The primary objective of the UNFCCC is to address global climate change and its impacts on the environment and human societies. The Convention provides a framework for international cooperation to stabilise greenhouse gas concentrations in the atmosphere at levels that prevent dangerous anthropogenic interference with the climate system.

The Convention establishes a framework for regular meetings of the Conference of the Parties (COP) to review and coordinate efforts to address climate change. The COP meetings bring together representatives from member countries to negotiate and make decisions on various aspects of climate change mitigation and adaptation.

The Kyoto Protocol, adopted in 1997 as an extension of the UNFCCC, set legally binding emission reduction targets for developed countries. It entered into force in 2005 and played a crucial role in shaping international climate policy.

The Paris Agreement, adopted in 2015 during COP21 in Paris, is a landmark international accord that builds upon the UNFCCC. It aims to limit global temperature rise well below 2 degrees Celsius above pre-industrial levels, with efforts to limit it to 1.5 degrees Celsius. Unlike the Kyoto Protocol, the Paris Agreement includes contributions from both developed and developing countries.

Malaysia ratified the Paris Agreement on 16 November 2016 and had submitted its updated Nationally Determined Contribution (NDC) to the UNFCCC in July 2021.

Malaysia intends to reduce its economy-wide carbon intensity1 (against GDP) of 45% in 2030 compared to 2005 level. The updated NDC includes the following increased ambition:

- a) The 45% of carbon intensity reduction is unconditional
- b) This target is an increase of 10% from the earlier submission; and
- c) The GHG coverage is expanded to seven (7) greenhouse gasses (GHG): Carbon dioxide (CO2), Methane (CH4), Nitrous oxide (N2O), Hydrofluorocarbons (HFCs), Perfluorocarbon (PFCs), Sulphur hexafluoride (SF6) and Nitrogen trifluoride (NF3).

UNFCCC-COP28

The hosting of UNFCCC-COP28 by the UAE government on 30 November to 12 December 2023 made history as one of the largest conferences in the world, attended by over 100,000 delegates from around the globe, including 156 heads of state and government, as well as 22 leaders of international organisations.

A total of 700 Malaysian delegates were registered by the Ministry of Natural Resources and Environmental Sustainability to participate in UNFCCC-COP28. Out of this number, 30 delegates, representing government officials from various ministries and agencies, attended the climate change negotiation processes. The remaining delegates, representing government ministries and agencies, private sector, and nongovernmental organisations (NGOs), participated in various programs and activities, including those held at the Malaysia Pavilion.



High Level Participation

Special Visit by His Majesty Seri Paduka Baginda Yang di-Pertuan Agong (YDPA) to the UAE in conjunction with UNFCCC-COP28


As the President and host country of UNFCCC-COP28, the Government of the UAE organised the World Climate Action Summit (WCAS) on 1st and 2nd December 2023, featuring the participation of Heads of States and Heads of Government.

His Majesty Seri Paduka Baginda Yang di-Pertuan Agong attended the opening session of WCAS and the initial segment of the High-Level Segment of UNFCCC-COP28 on 1st December 2023. He was accompanied by the Minister of Natural Resources and Environmental Sustainability, responsible for climate change issues, and the Minister of Investment, Trade, and Industry, serving as the accompanying minister.



On 1st December 2023, during the UNFCCC-COP28, His Majesty Seri Paduka Baginda Yang di-Pertuan Agong met His Excellency Shavkat Mirziyoyev, the President of the Republic of Uzbekistan. The former Minister of Foreign Affairs, the Minister of Natural Resources and Environmental Sustainability, and the Minister of Investment, Trade, and Industry of Malaysia were also present during the meeting. Discussions revolved around the prospects of enhancing bilateral cooperation in various priority areas, including trade, tourism, and education.

Furthermore, in response to an invitation from Her Excellency Emine Erdogan, the First Lady of the Republic of Turkey, Her Majesty Seri Paduka Baginda Raja Permaisuri Agong graciously delivered a speech at the Climate Talks for a Green Future at the Turkish Pavilion on 1st December 2023.



G77 and China Leaders' Summit

The Minister of Natural Resources and Environmental Sustainability actively participated in the inaugural Summit of the Leaders of the Group of 77 and the People's Republic of China on Climate Change (G77 & China Summit on Climate Change) on 2nd December 2023. During this significant event, the Minister delivered an intervention as part of the high-level general debate session.

In this inaugural summit, Malaysia emphasised the importance of unity within the G77 and China, acknowledging the slow progress observed since the Paris Agreement. Malaysia commended the establishment of the Loss and Damage Fund and called for transparent governance, urging predictable funds for developing countries. The nation advocated for a new direction in climate finance and reiterated the USD100 billion annual pledge from developed nations.

The importance of the Global Stocktake in the implementation of the Paris Agreement was stressed, with a plea for developed nations to support their developing counterparts. Post-COP28 steps were urged to align with equity principles, and the G77 and China were encouraged to uphold these principles in negotiations.

Malaysia highlighted the significance of the Global Goal on Adaptation Framework and called for flexibility in its adoption. Overall, the Minister emphasised that climate actions should adhere to equity and common but differentiated responsibilities.





Second Part of the High-Level Segment of UNFCCC-COP28

On 9 December 2023, the Minister of Natural Resources and Environmental Sustainability delivered the National Statement during the Second Part of the High-Level Segment of UNFCCC COP28. The statement emphasised Malaysia's commitment to taking action to achieve greenhouse gas (GHG) emission reduction targets under the Paris Agreement. This commitment includes the country's aspiration for net-zero GHG emissions, based on the principles of equity and the common but differentiated responsibilities with respective capabilities.

The statement also addressed legislative developments in Malaysia related to climate change, highlighting energy transition policies such as Malaysia's Energy Transition Roadmap, initiatives pertaining to renewable energy sources, energy efficiency measures, green electricity tariffs, and efforts towards reducing fossil fuel subsidies.

Bilateral Meetings Between the Ministry of Natural Resources and Environmental Sustainability and Other Countries and International Organisations



On 2nd December 2023, the Minister of Natural Resources and Environmental Sustainability engaged in a bilateral meeting with Hon. Marina da Silva, the Minister of Environment and Climate Change of the Federal Republic of Brazil. Matters discussed during the meeting included issues related to biodiversity and forest management, taking into account the current status of both countries as megadiverse nations and Brazil's preparation to host the UNFCCC-COP30 conference in 2025.

World Bank's Courtesy Visit to the Honorable Minister of Natural Resources and Environmental Sustainability

During the courtesy visit, the representative from the World Bank conveyed the institution's readiness to support Malaysia in its endeavor to transition the energy sector, particularly in shifting from coalbased electricity generation to renewable energy sources.

Southeast Asia is recognised as possessing significant potential in the realm of renewable energy. Several countries in the region, including Thailand, Vietnam, and Singapore, are formulating their respective strategies for the adoption of trade in renewable energy sources.

Simultaneously, the World Bank expressed appreciation for Malaysia's active participation in the Partnership for Market Implementation (PMI) program. This acknowledgment is particularly directed towards Malaysia's efforts in conducting preliminary studies for the implementation of carbon pricing initiatives. The World Bank has communicated its intention to organise a workshop focused on the carbon market mechanism within the forestry sector and extended an invitation to Malaysian representatives to partake in the event.

Presenter and Panelist at Side Events of UNFCCC-COP28

The Minister of Natural Resources and Environmental Sustainability was also invited as a panelist and presenter at various side events held during UNFCCC-COP28, as follows:

Bilateral Meetings with the Ministry of Foreign Affairs Held During UNFCCC-COP28



On 2 December 2023, the former Minister of Foreign Affairs engaged in discussions with the Minister of Foreign Affairs of Brazil, H.E. Mauro Vieira, on the sidelines of the Summit of the Leaders of G77 and China on Climate Change, exchanging views and addressing shared issues of interest.

The former Minister of Foreign Affairs also held a bilateral meeting with Hon. Shirley Ayorkor Botchwey, the Minister of Foreign Affairs and Regional Integration of the Republic of Ghana. During the meeting, the former Minister expressed the view that bilateral relations between Malaysia and Ghana could be enhanced, particularly in the areas of trade, investment, education, and human capacity building.

Climate-Health Ministerial Responding to the Health Impacts of Climate Change

National Statement at UNFCCC-COP28 Climate-Health Ministerial on the commitment and efforts of the Ministry of Health Malaysia in addressing the health impacts of climate change.

The Minister of Health emphasised the commitment of the Ministry of Health (MOH) to undertaking climate change adaptation and mitigation activities. MOH is dedicated to developing a health system that is resilient to climate change and fosters a low-carbon healthcare system.

Healthcare facilities significantly contribute to the carbon footprint, encompassing energy use, waste generation, and resource consumption. In line with the Malaysian Government's efforts to achieve net zero emissions as early as 2050, MOH remains steadfast in continually reducing carbon emissions from the health sector.

Urbanisation and Climate Change Ministerial Meeting



The Ministy of Housing and Local Government delivered the National Statement as the co-chair at the Urban and Climate Change Meeting (COP28) in Dubai. Malaysia is committed to developing zero net carbon cities and achieving net zero emissions as early as 2050 for a sustainable, green, and humane future.

The statement emphasises Malaysia's insistence on the transparent and prompt mobilisation of the loss and damage fund to empower vulnerable cities and local governments fully. These entities are crucial in leading the forefront of the battle against the climate crisis.

The singular pathway advocated is sustainable urbanisation and a commitment to a green future. The urgency of the situation demands immediate action, and collective efforts are essential to safeguard livelihoods and alleviate the impending climate catastrophe.

Time is of the essence, and there is no room for delay. The current scenario is described as a do-or-die situation, necessitating immediate and collaborative action. Failure to act collectively may result in the extinction of nations and cultures.

Main Outcomes of the Climate Change Negotiations at UNFCCC-COP28

The climate change negotiation at UNFCCC-COP28 involved key meetings such as:

- 1) The 28th Conference of Parties (COP28)
- 2) The 5th Conference of Parties serving as Meeting of the Parties to the Paris Agreement (CMA5)
- 3) The 18th Conference of Parties serving as Meeting of the Parties to the Kyoto Protocol (CMP18)
- 4) The 59th Subsidiary Body for Scientific and Technological Advice (SBSTA59)
- 5) The 59th Subsidiary Body for Implementation (SBI59)

The negotiation process at UNFCCC-COP28, initially planned to conclude on 12 December 2023, was extended until 13 December 2023. In summary, the outcomes of UNFCCC-COP28 have effectively stimulated inclusive efforts on a global scale to confront climate change and elevate aspirations toward achieving the goals of the Paris Agreement, encapsulated in a comprehensive package referred to as 'The UAE Consensus.'

A) First Global Stocktake (GST)

- a) To assess the implementation of the Paris Agreement includes, for the first time in the history of UNFCCC, specific references to fossil fuels and the need for a fair, phased, and equitable transition from fossil fuels in the energy system to sustainable alternatives.
- b) To increase global renewable energy capacity threefold and global energy efficiency rates twofold.
- c) All countries are urged to set higher and cross-economy emissions reductions targets when updating their Nationally Determined Contributions (NDC) in the future.
- d) 52 oil and gas companies at the national and international levels have committed to setting their decarbonisation targets.

B) Emirates Framework for Global Climate Resilience

- a) To enable member countries to adapt to the current and future effects of climate change.
- b) As a guideline for member countries to achieve global climate change adaptation goals. Under this framework, qualitative targets will be developed to be achieved by 2030.
- c) To appoint a consortium of the United Nations Office for Disaster Risk Reduction and the United Nations Office for Project Services as the host of the Santiago Network secretariat for a fiveyear period to provide technical assistance and capacity-building related to climate change adaptation, especially for developing countries.

C) In terms of climate finance, the importance of grant-based finance and the need to increase financing twofold to fund climate change adaptation actions have been emphasised. A new contribution of USD 188 million to the Adaptation Fund has been recorded, while for the Green Climate Fund (GCF), an additional contribution of USD 3.5 billion has been received in the second funding phase, bringing the total GCF funding to USD 12.8 billion. Moreover, various countries have committed to contributing USD 792 million to operate the Loss and Damage Fund established on the first day of the UNFCCC-COP28 conference. Private sector efforts and contributions to climate change mitigation are not overlooked, as a climate investment fund for the private sector worth USD 30 billion has been collected at UNFCCC-COP28.

Delegations from countries actively engaged in negotiation sessions to operationalise and implement various actions outlined in other articles of the Paris Agreement, encompassing:

- 1) For a fair energy transition, member countries agreed to the 'UAE Just Transition Work Programme,' and a dialogue session to detail this work program will be conducted in 2024.
- 2) For the mitigation work program, member countries are invited to submit any proposals as a basis for the work program to be discussed in a planned dialogue session in 2024.
- 3) Regarding response measures to climate change actions, issues related to climate actions seen as barriers to international trade were extensively discussed but were not included in the final decision text. Instead, member countries drew attention to and agreed for a work program considering a fair transition and functions to be developed. The functions and procedures of the Katowice Committee of Experts, acting as advisors assessing and recommending response measures, were also reviewed.

Nevertheless, specific negotiation agendas encountered challenges in attaining consensus and will remain subjects for discussion and negotiation in subsequent sessions. These issues encompass concerns regarding the scope and definition of cooperative approaches for market mechanisms compliance under Article 6.2, proposed amendments to authorisation decisions perceived as loosely defined and lacking high integrity, and the eligibility of removal activities to be considered within the scope of activities under the mechanism of Article 6.4.

Initiatives and Declarations Supported by Malaysia

During UNFCCC-COP28, Malaysia also supported various initiatives and declarations concerning climate change spearheaded by other countries and international organisations. These include:

- 4) COP28 Global Renewables and Energy Efficiency Pledge
- 5) Joint Statement on United for our Forests
- 6) Joint statement of the Group of Friends of Children and the Sustainable Development Goals



Malaysia's Participation

The Government of Malaysia, through the participation of various Federal and State Ministries and Agencies, attended UNFCCC-COP28. Over 35 Malaysian negotiators actively engaged in the negotiation process, concentrating on eight (8) key thematic areas outlined below:

- 1) Global Stocktake (GST)
- 2) Market & Non-Market Mechanism under Article 6
- 3) Just Transition/ Response Measure
- 4) Climate Finance including Loss & Damage Fund
- 5) Mitigation Work Program (MWP)
- 6) Adaptation including Loss & Damage
- 7) Agriculture
- 8) Transparency




